

**FILIPINO AMERICAN ASSOCIATION OF STAFFORD, VA
2019 EXECUTIVE OFFICER'S ELECTION**

Under the provisions of the FAASV Bylaws, ARTICLE XI-ELECTION states:

Section 1. Election of Officers shall be held annually at a General Meeting in March. Elected officers shall assume duty immediately on the first of April, and will be installed in May.

Section 2. The Board of Directors will manage and convene the election. The Board of Directors has the authority to call a special election to fill a vacant position.

Section 3. Eligibility requirements for Fil-Am Officers:

- a. Candidates for President and Vice President must possess a high level of knowledge regarding Filipino heritage and culture.
- b. For President, the candidate must be an active member, and in good standing for two consecutive years.
- c. For other officers, the candidate must be an active member, and in good standing for one year.

Section 4. Term limit for all executive board members is two years, or minimum of one year.

Section 5. The election of officers may be done by written ballots or by hand counting. A simple affirmative vote of the majority of all members present shall be necessary to elect an officer.

Section 6. Proxy votes will not be accepted for the election of the officers.

Section 7. Nominees must be present. If a member cannot be present and would like to run for a particular office, the member must submit a "letter of intent" to the Board of Directors for a particular position, as applicable. E-mail is an acceptable form of written intent.

Section 8. No elected/appointed officials can serve two positions at the same time.
